**RESPONSE:**

See Excel file, Ch 13 SoCalGas SGIP Allocation Data. See tab, “SCG Payments after 05-01-2019”, rows 126 to 194. The date of the payment is reflected in column M, column R is 50% receiving amount. Chapter 13 at page 31, Prepared Direct Testimony of Iftekharul (Sharim) Chaudhury, illustrates the hybrid method allocating half of the SGIP costs to the host customer classes and the other half allocating to the receiving customer classes. In Chapter 13 Workpaper under tab, “SCG Payments after 05-01-2019” column C is the host class and column O is the receiving class.
