INCENTIVES:


In addition to potential reductions in energy usage, participants could receive financial incentives in two ways:

- One way is based on total therms saved at the end of each year (\$.60/therm).
- The other is the potential to earn a total of \$5000 based directly on program participation. Speak with your ITI SEM coach for more information.

These incentives encourage your team to reduce energy waste now and in the future. Participation in ITI SEM occurs over a 2-year period. Energy saving projects typically begin by month six of the first year.
