This MEMORANDUM OF UNDERSTANDING (MOU) is hereby entered into by the California Public Utilities Commission (CPUC) and Southern California Gas Company (SoCalGas). Under this MOU, SoCalGas is requesting that the CPUC complete a pre-filing review of the SoCalGas draft application materials for the Ventura Compressor Station Modernization Project. This may include a completeness review of the Proponent's Environmental Assessment (PEA), draft application, and supporting materials; project start-up activities; meetings and site visits; and initiation of agency consultation prior to SoCalGas permit application filing. To cover the cost of pre-filing review, SoCalGas agrees to pay a deposit to the CPUC in the amount of \$52,000.00.

Any pre-filing review costs not recovered by the deposit will be invoiced to SoCalGas and paid accordingly. The amount will not exceed \$90,000.00. If any pre-filing deposit funds remain after the pre-filing period, they will be applied to the review of the filed application. The requirements of Rule 2.5 of the CPUC's Rules of Practice and Procedure are not to be impacted by this MOU.

SoCalGas will send the pre-filing deposit directly to the CPUC Fiscal Office at 505 Van Ness Avenue, San Francisco, CA 94102. The deposit will include a letter referencing the project name and Contract #CEQA070 for Aspen Environmental. At the time of project filing, the cover letter for the PEA will again reference this number as follows: "Pre-filing fees have been made under Contract #CEQA070. This is for CPUC tracking purposes and will allow the CPUC to credit any remaining pre-filing deposit toward application review".
